Exceed Advisory

Exceed Advisory's strategy is composed of an equity options component and a fixed income component. The options component uses call and put options on equity indices or broadbased equity ETFs in seeking to limit risk/return exposure to predetermined market levels. The fixed income component invests in investment grade fixed income securities for the purposes of generating income for the options strategy as well as collateral for the options.

Heritage Capital Advisors

Heritage espouses an active, risk managed, multi-strategy management style designed to algorithmically adapt to changing market environments. Six independent, risk-targeted strategy components are employed including strategic asset allocation, risk-managed asset allocation, a leaders-based hedged equity selection strategy, a daily long-short directional element, a tactical allocation system, and a fixed income allocation model.

Synergy Asset Management
