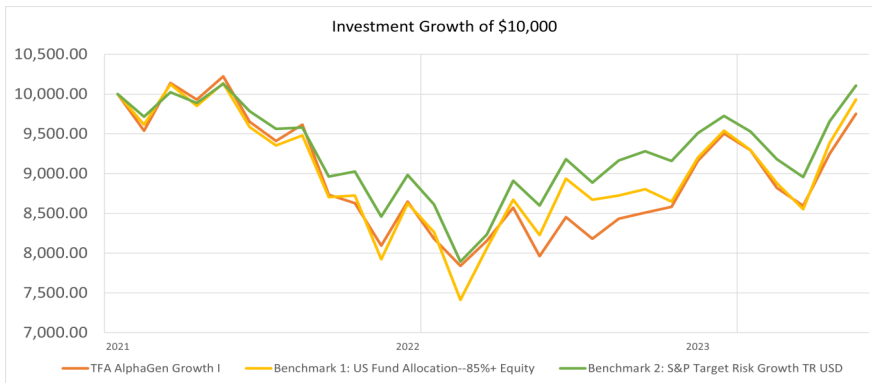

Various strategies may independently apply trend-following, mean-reversion, relative-strength, econometric and other methods to determine their respective share of the fund's total allocation. Using multiple approaches, the strategy seeks to create an ensemble view of the optimal positioning of the fund, reducing the potential impact of any single approach falling out of favor within a given market environment for more consistent long-term results.
